Roll call of officers: All present.

Mail: Rifleman, SAMS Newsletter, received a Certificate from SAMS

Winter Archery; Did not do so well over the winter. Is going to get more involved in outdoor events and would like to try again next year.

3-Gun Shoot: No new business

USPCA: Had a talk with "Master Blasters" club from NH. They have agreed to help us run the matches in exchange for a date, once a month, to hold a match in their name, preferably during the first Sunday of the Month.
